## DESCRIPTION

**BRICK CLEANER** is an acid based cleanser designed for the rapid removal of cement splashes, stains and algae growth from brickwork and concrete. This concentrated cleanser will quickly and efficiently restore contaminated bricks back to their original pristine condition. Ideal cement mixer cleaner.

**USES:** The general cleaning of all brickwork to rapidly remove mortar splashes, mortar stains and algae growth. Excellent impact cleanser for tired drab looking brickwork. New Build, garden walls, garages, steps, concrete pavements and driveways. For general cleaning of cement mixers to remove the "high build" cement.

**APPLICATION:** Wear protective clothing, i.e. Protective glasses, rubber gloves and overalls, to avoid skin and eye contact. Pour carefully and directly from the container into a deep tray. Apply onto the brickwork using a soft broom and spread over the contaminated areas. Work from the highest point. For stubborn areas repeat with further amounts of fresh Brick Cleaner as necessary. Do not allow the Brick Cleaner to contact any glass and grassed areas as this product will cause damage.

**RINSING** Best results are achieved using a hose pipe. Alternatively rinse with cold water using the soft broom. Care must be taken not splash yourself during this rinsing procedure.

**HEALTH AND SAFETY:** Always read the Health & Safety Data Sheet prior to handling this product. Avoid skin and eye contact. Should there be contact with your eyes, rinse immediately for 20 minutes with cold water and seek medical attention.

### **COVERAGE**

5 Litres should cover up approximately 25 square metres depending upon the extent of contamination that exists

### **SHELF LIFE**

24 months in sealed containers

### **PACK SIZES**

5 Litres or 25 Litres plastic bottles
